1. **Primary Election Day is Tuesday, June 6.** Polls are open from 6am to 8pm. For further information, including polling locations, call (609) 267-5723, ext. 209.
2. **Eastampton Township Hosted a Memorial Day Service on Friday, May 26.** Mayor Jay Springer, Township Council and the Eastampton Recreation Advisory Committee coordinated the annual service to commemorate the men and women who died while serving our country. Council Member Anthony Zeno, Master Sergeant Byron Wright, members of Boy Scout Troop 36, Mr. Kim Yee, Eastampton Fire Department Chief Jason Elischer and Eastampton Township Police Department Chief Joseph Iacovitti laid wreaths at Veterans Park across from the Manor House on Manor House Court.

6. **Township Awarded 2016 Clean Communities Grant of \$12,126.45.** New Jersey Clean Communities is a state-wide litter abatement program created by State legislation and managed by the New Jersey Department of Environmental Protection and the Clean Communities Council. The Clean Communities Act establishes a funding mechanism for the program by placing a user fee on manufacturers, wholesalers and distributors who produce litter-generating products.

7. **Cliver Park Parking Lot Expansion Completed.** The project consisted of adding thirty-two (32) additional parking spaces to accommodate the growing use of the popular community park, which includes ball fields, tennis courts, a walking path, a basketball court and playground. The project is funded by a 2015 Burlington County Park Development Grant secured by Eastampton Township Council.

9. **Eastampton Township Co-Sponsors Fishing Tournament on Saturday, June 10 at Iron Works Park in Mount Holly.** The annual event, co-sponsored by several area municipalities, will be held from 6:30am to 12pm. 10. **Eastampton Township Encourages Residents to Volunteer for Township Boards and Committees.** Residents can apply to serve on the Economic Development Advisory Committee, Environmental Commission, Land Use Planning Board and the Recreation Advisory Committee. 11. **Westampton Township Recreation Programs Open to Eastampton Township Residents.** Eastampton Township residents have the opportunity to register for any of the exciting programs and activities offered through the Westampton Township Recreation Department. 12. **PSE&G Continues Burlington County Gas Pipe Replacement Project on Woodlane Road.** The project, which includes the replacement of approximately 9 miles of older gas pipes throughout various Burlington County municipalities, will directly impact the entire span of Woodlane Road in Eastampton Township. Work will be conducted Monday through Saturday from 8am to 5pm. 13. **Fieldstone Associates, LLC Continues Site Work on Eastampton Place West on Woodlane Road, the Former Gregory's Furniture Site.** Fieldstone Associates, LLC received Land Use Planning Board approval for a mix-use project on the site. "Eastampton Place West" consists of 7 buildings totaling approximately 383,000 square feet, including over 12,000 square feet of commercial space, a 4,300 square foot clubhouse and 240 **market-rate** luxury apartment units ranging from 800 to 1,400 square feet each. The property is located adjacent to the existing Dunkin Donuts on Woodlane Road. Construction is scheduled to begin this summer and occupancy is scheduled to begin in 2018. Work is scheduled to be performed on weekdays, weather permitting, from 7am to 4pm. Work will occasionally be conducted on Saturdays during the same hours.
14. **Holgate Development, LLC Continues Construction on Eastampton Village II and III on Woodlane Road.** The project, consisting of 8 **market-rate** single family homes and 55 **market-rate** townhomes is located adjacent to the existing Sharbell development. Work is scheduled to be performed on weekdays, weather permitting, from 7am to 4pm. Work will occasionally be conducted on Saturdays during the same hours. Although vehicular traffic may be impacted in this area, roads will remain open throughout the project. Construction work is being performed by Blenheim Construction of Sicklerville and Township Engineer Environmental Resolutions is managing project oversight.
15. **Fieldstone Associates, LLC Continues Construction on Eastampton Place on Woodlane Road, next to CVS.** "Eastampton Place" consists of 5 buildings totaling approximately 199,000 square feet, including 5,600 square feet of commercial space and 140 **market-rate** luxury apartment units ranging from 1,000 to 1,350 square feet each. The 3-parcel property, most of which was formerly a junkyard, is located adjacent to the existing CVS pharmacy. Construction has begun and occupancy is scheduled to begin later

this year. Residents should expect some traffic delays due to utility work in this area. Work is scheduled to be performed on weekdays, weather permitting, from 7am to 4pm. Work will occasionally be conducted on Saturdays during the same hours. For more information regarding Eastampton Place, visit <http://eastamptonplace.com>.
